## **Plan Management Explained**

Plan Management is a service fully funded through the National Disability Insurance Scheme to NDIS participants to help them effectively manage their NDIS funds and ensure that they receive the supports and services outlined in their NDIS plans. Plan Management funding is **subject to individual requests, NDIA rules, and plan approval processes.**

## **A plan manager can:**

- Increase your financial and plan management skills
- Submit claims to the NDIA
- Pay providers
- Help you comply with NDIS rules and regulations
- Offer greater choice by enabling access to registered and non-registered providers
- Send monthly activity statements
- Offer budget management tools


