What is Early Childhood Intervention?

In essence, early intervention means taking action at the earliest possible stage to attain optimal outcomes for children. Early Childhood Intervention (ECI) encompasses services and assistance for children and their families during the crucial early developmental years when progress is most rapid.

Specialists in early intervention collaborate with families, equipping them with

strategies and enhancing their capability to support children in their day-to-day activities and routines, whether at home, at daycare, in school, or within the community.

What other types of early connections are available?

In the context of early childhood and support services, several types of early connections and programs are available to families and children. These programs are designed to promote early development, provide support, and build connections within the community. Some of these early connections include:

Early Childhood Education: This includes preschool programs and kindergartens that offer structured learning opportunities for young children to develop social and academic skills. Early childhood education can be a valuable early connection for children.

Parent Support Groups: These groups provide parents with the opportunity to connect with others who are facing similar challenges and joys in parenting. They offer a supportive environment for sharing experiences and seeking advice.

Playgroups: Playgroups are informal gatherings of parents and young children, often in a community setting. They promote socialisation, play, and early learning in a relaxed atmosphere.

Maternal and Child Health Services: These services offer regular check-ups and support for parents and infants to ensure that children are reaching their developmental milestones and are in good health.

Childcare Centres: Childcare centres offer a structured environment for children to play, learn, and interact with peers under the care of qualified professionals.

Community Events and Programs: Many communities host events and programs specifically for families with young children. These can include storytime at the library, art classes, and other community-based activities.

Health Services: Access to healthcare professionals, including paediatricians, can

be an essential early connection for monitoring a child's health and well-being.

Online Resources: The internet offers a wealth of resources for parents and caregivers, from parenting forums to early learning websites and apps.

These early connections are vital for supporting children's development and ensuring they have a strong foundation for a healthy and successful future. Depending on a family's needs and location, different types of early connections may be more relevant and accessible.

What is the NDIS Early Childhood Approach?

The NDIS Early Childhood Approach currently provides support to children under the age of 7. Commencing from **July 1 2023**, there will be a progressive expansion of the approach to encompass children under the age of 9. This transition is scheduled to unfold over the course of the next two years. This change aligns with the World Health Organisations definition of young children being 0 to 8 years of age.

The primary objective of this change is to ensure that children under the age of 9 receive the necessary support from an early childhood partner as they navigate the transition to primary school and continue to receive assistance afterwards,

The NDIS early childhood approach is how children younger than 9 and their families are supported. This encompasses children under the age of 6 who exhibit developmental delays and children under the age of 9 with disabilities.

Children under the age of 6 are eligible for support through this approach without the requirement of a formal diagnosis, particularly in cases where developmental concerns are evident.

For example, you might be concerned about how your child:

1. **Engages in recreational activities and physical play**
2. **Demonstrates self-sufficiency and independence**
3. **Socialises with other children**
4. **Effectively communicates their needs**

This approach is aligned with best practice guidelines in early childhood intervention, as established by [Reimagine Australia](#). The best practice approach comprises a set of fundamental principles that govern the interactions between early childhood practitioners and families of children with developmental delays or disabilities. The primary objective is to deliver a family-centric and inclusive approach to care.

How does the NDIS Early Childhood Approach work?

Throughout Australia (*excluding remote and very remote areas), **NDIS Early Childhood Partners** are available to assist families in accessing the support their children require via the early childhood approach. These Early Childhood Partners are local organisations that receive funding from the National Disability Insurance Agency (NDIA) to administer the early childhood approach.

These childhood partners have teams of professionals with experience and clinical expertise in working with young children with developmental delay or disability and their families. These family-centered supports are delivered using a best-practice model.

*If you live in an area that doesn't have an early childhood partner, and you have concerns about your child's development or disability you should first speak with your doctor, child health nurse, early childhood educator or other health professional. How do I apply for NDIS Early Childhood funding?



Determine Eligibility

- Must be 0 to 8 years old.
- Must reside in Australia and be an Australian citizen or hold a Permanent **OR** Protected Special Category Visa
- Must have a developmental delay or disability that significantly impacts their daily life.



Contact the NDIS

- Contact your to express your interest in applying for Early Childhood Funding. If you live in a remote or very remote area, someone from the NDIA will work directly with you, to connect you to supports.
- Phone the NDIS on **1800 800 110**



Complete an Access Request Form

- You will be required to fill out the [Access Request Form](#). This form collects information about your child's condition, your family, and your circumstances.



Gather Supporting Documents

- Collect relevant medical reports, assessments, and any other documents that provide evidence of your child's developmental delay or disability.



Access Assessment

- The NDIA will review your Access Request Form and supporting documents to assess your child's eligibility for Early Childhood Funding.



Planning Meeting

- If your child is found eligible, you will have a planning meeting with an NDIS representative to create a personalised plan. During this meeting, you'll discuss your child's goals and the supports they need.
- Additionally, you will be asked to elect one of the following funding options, self-management, agency management or plan management.



Plan Approval

- After the planning meeting, your child's NDIS plan will be created and approved. This plan outlines the funding and services they are eligible to receive.



Plan Implementation

- Once the plan is approved, you can start using the allocated funding to access services and supports taking into account your chosen method of funding management



Revisions and Adjustments

- Periodically, you will have plan reviews to assess your child's progress and adjust their plan as needed.



Important Information

- It's important to remember that the NDIS process can vary depending on your location, and there may be different considerations for specific circumstances. What is NDIS Plan Management?

Plan Management is a service fully funded through the National Disability Insurance Scheme to NDIS participants to help them effectively manage their NDIS funds and ensure that they receive the supports and services outlined in their NDIS plans.

A plan manager can:

- Increase your financial and plan management skills
- Submit claims to the NDIA
- Pay providers
- Help you comply with NDIS rules and regulations
- Offer greater choice by enabling access to registered and non-registered providers
- Send monthly activity statements
- Offer budget management tools

Here's a more detailed explanation:

Financial Management: NDIS Plan Management involves managing the financial aspects of an NDIS plan. This includes budgeting, paying invoices, and keeping track of expenditures to ensure that participants' funds are used in accordance with their approved plan.

Choice and Control: It's designed to give NDIS participants more choice and control over their supports. With plan management, participants can select their preferred service providers, including those who may not be registered with the NDIS.

Invoice Processing: Plan managers process invoices from service providers on behalf of the participant. They check that the invoices are accurate and comply with NDIS guidelines before paying them.

Record Keeping: Plan management services maintain detailed records of

expenses and payments, which are essential for transparency, accountability, and reporting to the NDIS.

Support and Guidance: Plan managers offer support and guidance to participants to help them understand their NDIS plan, make informed decisions about their services, and maximise the benefits of their funding.

Reduced Administrative Burden: Plan management can relieve participants and their families of the administrative burdens associated with managing NDIS funds, allowing them to focus on their care and well-being.

Funded by NDIS: Costs are covered by the NDIS under the CB Improved Life Choices' category and will not impact your other NDIS funded supports.

It's important to note that NDIS Plan Management is one of several options available to NDIS participants for managing their funds. Participants can also choose to self-manage their funds or have the National Disability Insurance Agency (NDIA) manage their plan. The choice of plan management depends on the individual needs and preferences of the participant.

Plan management offers flexibility and support, empowering NDIS participants to have more control over their services and funding while ensuring that they comply with NDIS guidelines and regulations.
